- 7. There was a motion by Don and a second by Jamie authorizing Richard to request a grant from the Sowers Club. Motion passed.
- 8. There was a motion by Don and a second by Amy to request a grant from the Woods Foundation to pay a salary for one or more CFIT E-board members. Motion passed.
- 9. Richard reports that we need to get people to write to their representatives regarding Federal Transit Funding.

- 10. Richard reported that the replica trolleys are on hold.
- 11. The banner and T-Shirts were on display for members to see.
- 12. It was suggested that the shopping bags should be priced at \$3.00 each. If they don't sell at that price reduce to \$2.00 each.
